New programs and changes to old programs are listed below.

In 2023, we have two events planned. A community event where the residents of Surrey will be invited to see the various developers showcase their plans in Downtown Surrey. A special guest or panel will be invited to speak at a networking event in November.

Finally, Elizabeth will continue to provide updated information on opportunities in Downtown Surrey to commercial and residential realtors as requested.


GOVERNMENT RELATIONS

During the summer, if we continue to receive funding from Canada Summer Jobs, the Click on Surrey team will return from May through August to assist local businesses with website, social media, filming, photography and graphic design needs.

SAFETY



Once our Renewal is confirmed, we will be expanding the Bike Patrol. On Monday and Saturday, there will be one team from 9:30am-5:30pm. Tuesdays to Fridays, we will have one team from 9am-5pm and another team from 10:30am-6:30pm. We hope this will serve the businesses better by increasing the number of teams on duty between 10:30-5pm when we get more calls for service.

The DSBIA is currently working with the RCMP, Surrey Fire Services, Bylaws and Community Services to come up with solutions to mitigate fires in the area.

Watch for more community safety breakfasts and lunches over the next year.

AREA ENHANCEMENT AND PLACEMAKING



Once our Renewal is confirmed, we will be expanding the Clean Street Program to include additional streets north of 104 Avenue.

We have plans for placemaking activities and events throughout the summer.

Our pilot program for large item pick-up will be continued although cut to six months per year.


